HYPER is the owner of the name "HYPER STIMULATOR" and owns the copyright, intellectual property, designs and concepts of all HYPER products, or products as listed in any HYPER literature or any other version of the HYPER products that are manufactured now or in the future. The Purchaser or any legal structure or venture the Purchaser is involved in, herein after called the Purchaser, cannot at any time, now or in the future, manufacture complete HYPER product or components for HYPER product or other versions of a product, of any description, having a resemblance to complete HYPER product or components for HYPER product.

**Private Home Use.** HYPER hereby grants the Purchaser a nonexclusive right and licence to use for Private Home Use the HYPER product and associated HYPER products ordered on this order form. The Purchaser or any legal structure or venture the Purchaser is involved in, cannot at any time, without the express written permission of HYPER, use for any other purpose other than Private Home Use, the components for HYPER product, or complete HYPER product or other versions of a product, of any description, having a resemblance to components for HYPER product, or complete HYPER product. Use other than Private Home Use is strictly prohibited, is an infringement of copyright and will result in legal liability. The definition of "Private Home Use" excludes the use of HYPER product at locations such as clubs, hotels or any public place, or for exhibiting, renting, hiring, selling, lending, any public performance or any commercial use.

**Delivery** HYPER makes no claims regarding delivery dates. HYPER will make every effort to deliver within 4 weeks of this order, but if HYPER cannot deliver in this time, HYPER will at the Purchaser's written request, refund the deposit in full, except in the case of custom product, in which instance 20% of the total price is not refundable.

**Modifications.** The HYPER product must not be modified in any way without the prior written permission of HYPER.

**Kits and Plans.** HYPER permits the purchaser of a HYPER product kit containing chassis plans, to cut one (1) only set of chassis components for their own use only. The purchaser may not let any third party copy part or all of these plans.

**Your Computer.** If your computer was purchased from a party other than HYPER, then the purchase cost of a HYPER product does not include the configuring or setting-up of your computer.
